## AUTHOR BIOGRAPHICAL NOTES (IN ORDER OF APPEARANCE)

**David Campbell** is the Packey J. Dee Professor of American Democracy and the chairperson of the Political Science Department at the University of Notre Dame. His most recent book is *Seeking the Promised Land: Mormons and American Politics* (with John Green and Quin Monson). He is also the coauthor (with Robert Putnam) of *American Grace: How Religion Divides and Unites Us*, which received the 2011 Woodrow Wilson Award from the American Political Science Association for the best book on government, politics, or international affairs, in addition to the Wilbur Award from the Religious Communicators Council for the best nonfiction book of 2010. He is also the author of *Why We Vote: How Schools and Communities Shape Our Civic Life*, the editor of *A Matter of Faith: Religion in the 2004 Presidential Election*, and a coeditor of *Making Civics Count: Citizenship Education for a New Generation*. In addition, he has published articles in a wide variety of academic journals, including the *American Journal of Political Science*, the *Annual Review of Political Science*, the *Journal of Politics*, and *Public Opinion Quarterly*. As an expert on religion, politics, and civic engagement, he has often been featured in the national media, including the *New York Times*, the *Economist*, *USA Today*, the *Washington Post*, the *Wall Street Journal*, *Time*, NBC News, CNN, NPR, Fox News, and C-SPAN.

**Dr. Jeff Adams** is an associate professor of supply chain management in the University of Houston Downtown College of Business. His research interests are on small business, buyer-supplier partnerships, and purchasing maturity. He has numerous articles and presentations. He holds a PhD in materials management, logistics, and operations from the George Washington University, and an MBA with concentrations in finance and total quality management from Xavier University.

**Dr. Chris Harris** is an associate professor of supply chain management in the University of Indianapolis School of Business. His research and teaching interests focus on lean supply chain production systems. He is the author of numerous articles and several books on lean production principles. He holds an MBA and a DBA with a major in management from Anderson University in Anderson, Indiana, as well as a master of science degree in youth development leadership from Clemson University.

**Dr. Kathy Bohley Martin** is a professor of international business and marketing in the University of Indianapolis School of Business. She has taught for almost two decades and has received numerous teaching, service, and scholarship awards, including best paper on three occasions. Dr. Bohley Martin has been awarded more than 20 grants, nominated twice for Teacher of the Year, and awarded Outstanding Advisor of the Year for a student organization. Moreover, she has presented more than 100 times at conferences and workshops and has published numerous articles in international peer-reviewed journals.

**Douglas Dixon** received his PhD from the University of Georgia in 1997. His work has been published in various peer-reviewed journals on topics such as American politics, history, political and history education, and undergraduate preparation. He has taught government and history since the 1980s at public schools, colleges, and universities. He is currently finishing a book manuscript about a Hoosier soldier coming of age.

**Dr. Joseph Ferrandino** is an associate professor of criminal justice in the School of Public and Environmental Affairs at Indiana University Northwest. His research interests include criminal justice pedagogy and policy analysis from a variety of perspectives. His work has appeared in more than 10 peer-reviewed journals.

**Dr. Jonathan Furdek** is a professor of operations management in the School of Management at Purdue University Calumet, Hammond, Indiana, where he teaches courses in operations management and business statistics. He earned his PhD from the Krannert School of Management, Purdue University, in industrial economics. His research interests focus on fringe benefits, especially pension benefits, and on the operations of new enterprises, especially businesses that export or displace imports from outside the economic region.

**Dr. John Lucas**, previously a human resource professional at Commonwealth Edison in Illinois, is a professor of management in the School of Management at Purdue University Calumet. He earned a master of science in industrial relations (MSIR) and PhD from Loyola University in Chicago. His research interests are in the areas of labor relations, employee benefits, and performance management.

**Irene Gichungeh** is a registered nurse working at nursing homes. She obtained her MPA from the Department of Public Policy at Indiana University–Purdue University Fort Wayne in 2013. She received a one-year graduate research assistantship from the Graduate School at Indiana University–Purdue University Fort Wayne from fall 2012 to spring 2013.

**Ae-Sook Kim** is an assistant professor at the Department of Public Policy at Indiana University–Purdue University Fort Wayne. Her research interests include state politics, the policy-making process, the impacts of social and health policies, and health care quality improvement especially focusing on nursing homes. She has published in the *Policy Studies Journal*; the *Journal of Health Politics, Policy and Law*; the *International Journal of Educational Reform*; and the *International Journal of Policy Studies*.

**Dr. Kathleen A. Tobin** is associate professor of history at Purdue University Calumet. She teaches both U.S. and Latin American history, including courses on the history of the Caribbean. Her research interests include both Haiti and population policy, and her article “Population Density and Housing in Port-au-Prince: Historical Construction of Vulnerability” was recently published in the *Journal of Urban History*.

**Jason VanAlstine** is an assistant professor of economics in the School of Business at Indiana University Kokomo. He teaches undergraduate courses in economics and statistics. He is a member of the Faculty Colloquium on Excellence in Teaching and has won multiple teaching awards. Jason's research focuses on the economics of diversity and the scholarship of teaching and learning and has resulted in five publications.

**Steven R. Cox** is a professor of finance in the School of Business at Indiana University Kokomo. He teaches graduate and undergraduate courses in finance, accounting, and economics. He also teaches in the Freshman Learning Community and the Honors Program. He is an award-winning teacher, and his publication outlets include the *Journal of Money, Credit, and Banking*, the *Journal of Banking and Finance*, and the *Journal of Corporate Finance*.

**Dianne M. Roden** is a professor of finance in the School of Business at Indiana University Kokomo. She has taught both undergraduate and graduate courses in finance and accounting and has received eight awards for teaching excellence. Dianne's major focus of research is on issues of corporate ownership and control and has resulted in more than 20 refereed articles published in high-quality journals.

**Joe Wert** is an associate professor of political science at Indiana University Southeast, where he currently serves as dean of the School of Social Sciences. He received his PhD in political science from the University of Cincinnati. He is the author of *A Study of Bill Clinton's Presidential Approval Ratings* (Edwin Mellen Press). His research interests include the U.S. presidency and public opinion.

**Cliff Staten** is professor of political science at Indiana University Southeast. He received his PhD in political science from the University of North Texas. He is the author of two books: *The History of Cuba* (Greenwood Press) and *The History of Nicaragua* (ABC-CLIO). He is currently working on the forthcoming *Historical Dictionary of Nicaragua* for Scarecrow Press. He has published on a wide variety of topics, including U.S. foreign-policy decision making, Hezbollah, 9-11, and IMF economic conditionality agreements.
