PROGRAM DESCRIPTION

This program provides funding to LEAs to establish or expand elementary and secondary school counseling programs, with special consideration given to applicants that can:

Demonstrate the greatest need for counseling services in the schools to be served; Propose the most innovative and promising approaches; and Show the greatest potential for replication and dissemination.

TYPES OF PROJECTS

Projects should:

- (1) use a developmental, preventive approach,
- (2) expand the inventory of effective counseling programs,
- (3) include in-service training, and
- (4) involve parents and community groups.

RESULTS MEASURES

The GPRA measures for this program are:

- (1) The percentage of grantees closing the gap between their student/mental health professional ratios and the student/mental health professional ratios recommended by the statute.
- (2) The average number of referrals per grant site for disciplinary reasons in schools participating in the program.

SUGGESTIONS

- (1) Make schools/districts aware of the program.
- (2) Assist schools with an initial application, including gathering/analyzing baseline data; demonstrating need; writing grant language; etc.
- (3) Assist with requirement for professional development -- use this opportunity to talk about evidenced-based school counseling.
- (4) Assist with ongoing data analysis and reporting.
