Dr. **Krishna T. Kumar** is currently an adjunct professor in the Department of Statistics, George Washington University, Washington, DC. From 2000 to 2010, he was an adjunct professor at the Indian Institute of Management, Bangalore. Prior to this, he was a visiting professor at the School of Management, Arizona State University-West, Phoenix; Director of the Institute for Behavioral Research, Florida Atlantic University; Professor of Economics and Statistics at Florida State University; a senior scientist at Abt Associates, a leading social science consulting firm in the Cambridge–Boston area, and a visiting professor at Northeastern University, Boston. He was Professor and Head of the Economic Analysis Unit at the Indian Statistical Institute, Bangalore, and Professor of Economics and Statistics at the Indian Institute of Management. He was Professor of Economics at the University of Hyderabad and the Indian Institute of Technology, Kanpur. He is a founding member of the CR Rao Advanced Institute for Mathematics, Statistics, and Computer Science, Hyderabad. He received his PhD in economics from Iowa State University, USA.

**Christie Byun** is an assistant professor of economics at Wabash College in Crawfordsville, Indiana. She received her BA in economics from the University of California, Berkeley, and her PhD from the University of California, Riverside. Her research interests include applied econometrics, environmental economics, and the economics of the Alaska Native Claims Settlement Act.

**Karl Besel**, PhD, is an associate professor and graduate program director in the Department of Public Administration and Health Management at Indiana University Kokomo. Dr. Besel also served as Visiting Scholar of Community Philanthropy at the Center on Community Philanthropy, Clinton School of Public Service (University of Arkansas) in 2009. He holds a doctoral degree from the School of Business from the University of Louisville, Kentucky, where he specialized in organizational administration.
