## AUTHOR BIOGRAPHICAL NOTES (IN ORDER OF APPEARANCE)

**M. Todd Bradley**, PhD, is an associate professor of political science at Indiana University Kokomo. His research areas include civil society actors, such as nonprofits and nongovernmental organizations (NGOs), and the roles they play in democratization efforts in “developing” countries. Additionally, his research focus considers the role of NGOs in societies, such as that of Japan, that have traditionally marginalized (or overlooked) civil society actors in “mature” democracies.

**Emmett Dulaney** is a professor of marketing in the Falls School of Business at Anderson University. His areas of interest include consumer behavior, public relations, and social media.

**Rebecca Gunn** is an assistant professor of marketing in the College of Business at Oral Roberts University. She received her DBA in marketing from Anderson University (Indiana). Her research interests include marketing communications, consumer behavior, eWOM, and social media.

**Nuan Gao** is Assistant Professor of East Asian History, Department of History, Hanover College, Indiana. Her research interests focus on the cultural and social transformations of late-nineteenth-century and early-twentieth-century China.

**Sara Hare** is an associate professor of sociology at Indiana University Southeast. She received her PhD in sociology from Indiana University Bloomington in 2002. Dr. Hare teaches courses in gender roles, social movements, statistics, and research methods, and she researches topics in the area of gender and media.

**Gregory T. Kordsmeier** is Assistant Professor of Sociology at Indiana University Southeast. His research focuses on social interaction in culture industries. He utilizes qualitative methods in that research, focusing on in-depth interviewing, participant observation, and qualitative content analysis of documents. In particular, he is interested in understanding the social-psychological and micro-sociological forces that affect work processes in arts organizations, and the effects this has on artists and the art that they make.

**Payton Schnarre** graduated with a bachelor’s degree in psychology from the University of Southern Indiana in 2015. She is currently pursuing a master’s degree in social work at the University of Southern Indiana.

**Aimee Adam** is an assistant professor in the psychology department at the University of Southern Indiana. Her research focuses on the impact of the media on romantic relationships, the formation of parasocial relationships, and teaching-related issues.

**Anne Statham** received her PhD in sociology from Indiana University in 1976 and has taught at the University of Southern Indiana since 2007. Before that, she was on the faculty at University of Wisconsin–Parkside for many years; there, she led a multiyear

study of the Chrysler plant shutdown that occurred in late 1988. She was inducted into the Kenosha Labor and Education Hall of Fame in 1996 in honor of her work on this project. She has published a number of books and articles on a range of issues, including gender and work, women and poverty, identity in interaction, and environment and society.

His interests include the sociology of work, along with the impact of race, class, and education on members of the working class.
