2003 Annual General Meeting

From the Secretary...

The 2003 Annual Meetings of the Hindu-Christian Studies Society were held in Atlanta, Georgia. On Friday night we enjoyed a panel on the winner of the "Best Book in Hindu-Christian Studies, 2000-2002," which was Corinne G. Dempsey's Kerala Christian Sainthood: Collisions of Culture and Worldview in South India (Oxford, 2001). Many thanks to the members of the book award committee, for their hard work picking a winner among so many strong contenders. Thanks also to those who participated in the panel, including Mathew Schmalz, Anne Monius, Joanne Waghorne and Francis X. Clooney, Selva Raj (presider) and Corinne herself, for their provocative questions and comments. As Parimal Patil, chair of the Book Committee, remarked, judging by the quality of books submitted, the field of Hindu-Christian Studies appears to be in very good health.

Another high point of the meetings last year was Saturday morning's panel organized around the question, "Can Women Become Priests?" The papers presented by Susan Ross, Maura Ryan, Vasudha Narayanan and Laurie L. Patton raised fascinating issues about the relationship between authority, gender and "eligibility." Many thanks to the panelists for participating, to Leslie Orr for her thought-provoking response and to Deepak Sarma for gracefully presiding.

President Rachel Fell McDermott began our annual business meeting by inviting commemorations of the lives of two recently deceased members of the society: Judson Trapnell and Fr. William Cenkner. These were followed by a moment of silence.

According to our treasurer, Bradley Malkovsky, the financial health of the society is good, and the membership is increasing, but needs to increase more substantially to ensure the sound future of the society.
