While predictions of an open-access revolution have fallen short, the article rightly notes that a well-managed repository can bring contributors other benefits. These include:

- A publishing venue for unique materials
- An opportunity for scholars to expand their audience
- A place for scholars to resurrect their early work
- A place to showcase work that is unique to the university (e.g., student scholarship, legacy collections, administrative documents, etc.)

Butler Libraries has observed an additional benefit through feedback from up-and-coming faculty. When combined with [SelectedWorks](#), our repository provides contributors with a means to share their scholarship with prospective employers.
